- The statutory basis on which the Chief Executives/Leads of the 44 Sustainability and Transformation Partnerships were appointed.
- The statutory basis on which the Independent Chairs of the 44 Sustainability and Transformation Partnerships were appointed.
- The appointment process for the Chief Executives/Leads of the 44 Sustainability and Transformation Partnerships
  - ( I am interested here in understanding who took the decision to appoint, for example the name of a committee, body or individual within NHS England)
- The appointment process for the Independent Chairs of the 44 Sustainability and Transformation Partnerships
  - (Again, I am interested here in understanding who took the decision to appoint, for example the name of a committee, body or individual within NHS England)
- The title of the person within NHS England who is responsible for the performance appraisal for each of the Chief Executives/Leads and Independent Chairs of the 44 STPs
- The job description for the Chief Executives/Leads and Independent Chairs of the 44 STPs
- The statutory basis on which NHS England issued the consultation "Implementing the NHS Long Term Plan Proposals for possible changes to legislation"

The statutory basis on which the Chief Executives/Leads of the 44 Sustainability and Transformation Partnerships were appointed.

The statutory basis on which the Independent Chairs of the 44 Sustainability and Transformation Partnerships were appointed.

It may help if we explain that Sustainability and Transformation Partnerships (STPs) are not legal entities in their own right, rather they are areas covering all of England, where local NHS organisations and councils drew up shared proposals to improve health and care in the areas they serve.

As an STP is not a legal entity, it doesn't have a Chief Executive Officer.

STP chairs and Independent Leads are appointed as per the process set out later in this response and not by any one organisation alone. They are not statutory appointments.

The appointment process for the Chief Executives/Leads of the 44 Sustainability and Transformation Partnerships

The appointment process for the Independent Chairs of the 44 Sustainability and Transformation Partnerships

The lead of each STP was either identified through local agreement on who had the confidence of local parties to carry out this leadership role, or where this was not the case the lead was identified through open competition.

These competitions were conducted locally, with a local host as the employing organisation and Chairs, where in place, were identified in a similar way.

Following the publication of the NHS Long Term Plan requiring more formal system governance, the appointment process was updated:

- The general rule is that both STP leads and chairs should be appointed through open competition, including publicly advertising the role, a person specification for the role, and considering applications on a fair and consistent basis from anyone who meets the person specification.
- The exception to this general rule is where an STP wishes its lead to be an
  existing NHS Trust chief executive, Clinical Commissioning Group accountable
  officer, or senior council leader, who would combine the role with their
  existing role. In these circumstances the role does not need to be advertised
  publicly but there should be a fair process for determining which of its
  existing leaders should fulfil the role.
